The University Degree Programme in Business and Economics combines theoretical, methodological, and applied knowledge in business and economics. The programme uses the most advanced knowledge management and analytical tools to develop and train students for employment. Students gain basic theoretical knowledge to use in practice. Graduates of the programmes are qualified to perform the most demanding professional tasks in industry and public administration, depending on which of the specialisation chosen.

Study programme learning outcomes

The key objectives of the programme:

Key objective 1: A graduate acquires an advanced level of knowledge and understanding of the concepts in the field of business and economics.

- Key sub-objective 1.1: A graduate knows the concepts and theory and is capable of using them in the framework of microeconomic analysis.
- Key sub-objective 1.2: A graduate knows the concepts and theory and is capable of using them in the framework of macroeconomic analysis.
- Key sub-objective 1.3: A graduate understands the managerial process in a company and knows how to distinguish between managerial and business functions.
- Key sub-objective 1.4: A graduate acquires functional knowledge in marketing, finance, accounting, human resource management as well as production and service process management.
- Key sub-objective 1.5: A graduate knows how to analyse and recognise the impacts of the external and internal business environment on a company.

Key objective 2: A graduate acquires knowledge about the main research methods used in economics and business fields for the purpose of defining problems and solutions.

Admissions Criteria

Admissions criteria for the First cycle University Degree Programme in Business and Economics are as follows:

- a) a general matura certificate;
- b) a vocational matura certificate from an appropriate upper secondary vocational education programme or technical education programme in economic technician or in computer technician and general matura subject Mathematics. If the candidate has already taken the subject Mathematics at the vocational matura, then another subject from general matura will be accepted: economics, informatics, foreign language (English, German, French, Italian, Spanish or Russian), psychology, computer science, sociology or history.
- c) final examination certificate from an appropriate four-year upper secondary school programme completed before 1 June 1995.

All candidates enrolling in a study programme conducted in English language must prove English language proficiency at B2 level according to the Common European Framework of Reference for Languages (CEFR) with an adequate certificate.

In cases where available spots are limited:

candidates from item a) will be selected according to:

- The results of general matura - 60% of the points,
- GPA during your 3rd and 4th year of high school - 40% of the points.

candidates from item b) will be selected according to:

- The results of vocational matura - 20% of the points,
- GPA during your 3rd and 4th year of high school or trade school - 40% of the points,
- The results of the general matura subject - 40% of the points.

candidates from item c) will be selected according to:

- The results of secondary school final exams - 60% of the points,
- GPA during your 3rd and 4th year of high school or trade school - 30% of the points,
- The results of the subject Mathematics in the 3rd and 4th year of high school or trade school - 10% of the points.

Implementation of the full time University Degree Programme in Business and Economics is in Slovenian and English language.

At the application deadline for citizens of the Republic of Slovenia and citizens of EU Member States, when applying for full-time and part-time in eVŠ, it will be possible to select only implementation in the Slovenian language.

At the application deadline for Slovenians without Slovenian citizenship and the application deadline for Citizens of non-EU countries, when applying for full-time study in eVŠ, it will be possible to choose between implementation in Slovenian and in English language, and only Slovenian when applying for part-time studies.

The study programme is offered as a full-time and part-time programme. Part-time study programme is implemented in Slovenian.
